

Community Charity Matching Grant Program Instructions

PLEASE READ CAREFULLY AS EXPLANTION ALL OF THE RULES AND GUIDELINES THAT MUST BE FOLLOWED FOR YOUR APPLICATION TO RECEIVE CONSIDERATION ARE BELOW.

Note: The Community Charity Matching Grant Program is separate from the Scholarship Matching Funds Program. Further information on these programs is available by emailing the North Dakota Masonic Foundation at grandlodge@nd-masons.com or call 701-235-8321.

The Community Charity Matching Grant program was established by the North Dakota Masonic Foundation (NDMF) to encourage lodge activity, affording North Dakota Masons the ability to provide support to local charities and connect with the communities in which they live. The NDMF supports Masonic Lodges throughout North Dakota by matching community grant monies, effectively doubling the impact of the Masonic gift to the community.

A lodge may apply for Community Charity matching grants up to \$1,000 for one or more local, charitable programs or events during the fiscal year July 1 - June 30. Completed applications can be submitted anytime as they are processed quarterly. If a lodge wishes to spread its contributions between various charities throughout the year, it can be done through multiple submissions or through one submission if all details are indicated by the lodge.

What charities does the Foundation provide funds for?

The Foundation supports local, charitable programs, including, but not limited to, the following examples:

- Food and clothing for the needy Local Salvation Army efforts Special efforts to aid youth and the aged
- Equipment for school programs Local parks and facilities
- Community fire, police and health programs

- 501c3 charitable organizations
- Advanced learning opportunities

What charities are NOT eligible under the Community Charities program?

- Masons and their families
- Masonic groups
- For-profit companies

- National charity programs (e.g. American Red Cross)
- Church or synagogue programs that favor any specific religion or creed
- Individual causes without a charitable purpose
